## Summary

- A resolution was passed approving Corlett Trenching & Plumbing, LLC as a subcontractor to Terrace Construction Co. to replace lead service lines.
- Another resolution was passed to execute official deeds, per the Land Reutilization Program, selling various properties for \$200.

- Do the service lines impact residents or community activity?
- How long will it take to replace the service lines?

- The first order of business was four recommendations to approve contracts for Corlett Trenching as subcontractor to Terrace Construction Co.
  - There was a question about whether there would still be lead service lines in the areas of work. The answer was: "In very small portions."
  - Approving Corlett as subcontractor to Terrace Construction under City Contract No. RC2023-036 for materials, labor and installation necessary to

replace lead and galvanized service lines – CWD Lead Service Replacement 2022-1.

- Approving Corlett as subcontractor to Terrace Construction under City Contract No. RC2023-037 for materials, labor and installation necessary to replace lead and galvanized service lines – CWD Lead Service Replacement 2022-2.
  - Approving Corlett as subcontractor to Terrace Construction under City Contract No. RC2023-038 for materials, labor and installation necessary to replace lead and galvanized service lines – CWD Lead Service Replacement 2022-5.
  - Approving Corlett as subcontractor to Terrace under City Contract No. RC2023-039 for materials, labor and installation necessary to replace lead and galvanized service lines – CWD Lead Service Replacement 2022-6.
- Each resolution was passed unanimously and adopted.
  - The next item of business included a resolution to sell parcels for side lot yard expansions to several buyers for \$200.
  - The next portion of the meeting was presented by Hernandez, but her presentation was hard to hear on the livestream.
  - There was some discussion after Hernandez's presentation, but the resolution was passed unanimously.
  - There was no further discussion, and the meeting was adjourned at 3:10 p.m.
