## **Summary**

- Public speakers shared the importance of standing together and their intolerance
  of the anti-semitic and anti-LGBTQ+ comments made the previous week. The
  speakers said the comments did not represent the diversity and inclusion that
  Cleveland is working toward building within its communities.
- A public speaker also spoke on the impact of improving transportation in the city.
   While some strides have been made in this regard, including the <u>Superior Midway</u> <u>project</u> and the <u>Memorial Bridges Loop project</u>, there is still a tremendous amount of work to be done, she said.
- The youth curfew law was also discussed with great passion as it relates to minors being out extremely late and the curfew law is not being enforced to address this concern or to hold adults responsible/accountable, according to Council Member Mike Polensek. [Editor's note: Without any opposing votes, council approved increased punishment for parents and guardians of kids who break curfew. Jail time is possible.]

# **Follow-Up Questions**

- When did the curfew law stop being enforced? Who dropped the ball on enforcing and taking responsibility for minors being out past curfew?
- Could there be an alternative to public comment within the meetings that will allow freedom of speech but also protect the rights of protected classes within the City of Cleveland and our communities. What does this alternative look like (i.e absentee comments, screened comments, etc.)?

The meeting started at 7:04 p.m. and ended at 7:55 p.m. Everyone appeared cooperative and considerate of others as they were speaking. Public speakers were enthusiastic and passionate about the issues they were addressing. Council publicly recognized and
