# **Emergency Ordinance 1293-2023**

Authorizing the director of Public Safety to apply for and accept a grant from the United States Department of Justice, Bureau of Justice Assistance for the FY 2023 Justice Assistance Grant – Local Solicitation; authorizing one or more contracts with Cuyahoga County and various cities; and authorizing the purchase by one or more contracts of one mobile security unit.

Change the maximum age to enroll to become a police officer from 39 to 54 for first appointment to the Division of Police.

VIII, Section 13 of the Ohio Constitution.

Authorizing the director of Community Development to enter into one or more grant agreements with various entities to assist with a lead safe program using a portion of the city's Coronavirus Local Fiscal Recovery Fund, as authorized under Ordinance No. 119-2022, passed May 23, 2022, as amended by Ordinance No. 995-2022, passed Oct. 24, 2022.

Ordinance for three lots in Ward 5 to go back into the city land bank so that they are not abandoned.

## **Emergency Ordinance 1254-2023**

To amend the fourth clause and Section 1 of Ordinance No. 671-2023, passed June 5, 2023, relating to authorizing the director of Community Development to provide financial assistance to projects providing housing in the City of Cleveland.

## **Emergency Ordinance 1233-2023**

To amend Section 9 of Ordinance No. 371-2022, passed May 16, 2022, relating to conducting the Exterior Paint Program.

Amend sections 86 and 41 of Ordinance 194-202 passed March 29, 2021, as amended, relating to salaries for various classifications.

# **Emergency Ordinance 1372-2023**
