Report of a house fire. E1 and T1 on scene first. They found a vacant 2.5 story frame house with fire on exterior of division 1 and 2. E1 and T1 started a transitional attack. They knocked the exterior fire. E7, L7, E2, B2 on scene. Initial hand line taken inside to division 1. E7 took a second line to Division 2. Fire eventually under control. Companies did salvage and overhaul.

FGF Truitt was transported by EMS to Metro for a shoulder injury. B2 called for Car 713 to investigate. All companies deconed before going in service.
