E13 backup/water supply

Fire appeared to originate in the closet of the bedroom on side 2 of division 1. Car 713 determined the cause to be electrical in nature

Extension to the second floor via the side 2 wall channels and a hole burned through the second story floor above the first floor bedroom closet.

The fire was knocked by E11 initial attack line and the structure was hydraulically ventilated.

All hands on overhaul, AC1 also on scene as safety officer.

FIU remained on scene for investigation, Red Cross called to scene for assistance
